Subject:	Consideration of Amending CalPERS Resolution Delegation of Authority to Request Employer Disbursements from the CalPERS California Employers Benefit Trust Fund

Recommendation

It is recommended that the Town Council adopt the CalPERS Resolution amending its delegation of authority to authorize additional positions to request disbursements from the California Employers Benefit Trust Fund (CERBT).

Background and Discussion

The Council adopted Resolution No. 1825 in May 2013 approving an agreement to participate in the California Public Employees Retirement System (CalPERS) to prefund retiree benefits through participation in the California Employer Retiree Benefit Trust Program (CERBT).

Under the terms of the agreement, the Council authorized the Town Manager to submit disbursement requests from CERBT as needed. However, any disbursement request over the amount of \$10,000 requires two authorized signatures. Therefore, staff would like to amend the CalPERS resolution and add the positions of Council Members and Town Clerk as authorized signers.

WHEREAS, the California Public Employees Retirement System (CalPERS) has established the California Employers Benefit Trust Fund (CERBT) for California Public Agencies to use to prefund retiree health and other post employment benefit costs; and

WHEREAS, to participate in the CERBT program, CalPERS requires the Town Council to approve the accompanying agreement; and

NOW THEREFORE BE IT RESOLVED, the Town Council of the Town of Ross hereby adopts the agreement with the California Public Employees Retirement System (CalPERS) to prefund retiree medical benefits through participation in the California Employers Benefit Trust Fund (CERBT); adopts the resolution delegating authority to request disbursements from the Trust; approves the certification of the Program Funding Policy; and, approves the transfer of \$26,000 to CalPERS to establish the Trust.
