The African American Tobacco Control Leadership Council (AATCLC) supports the Youth Advocacy Committee's (YAC) request to implement an "Endgame Initiative" to prevent the issuance of tobacco sales licenses in the Town of Ross, ensuring that the Town remains free of commercial tobacco retailers.

As the Trump Administration continues to weaken public health systems and exacerbate health disparities, cities like Ross have both the authority and the responsibility to implement measures to protect their residents. Strong local policies to reduce and/or prevent commercial tobacco use are essential to protecting young people, and the broader community from the predatory marketing practices used by the tobacco industry to make addictive nicotine and tobacco products attractive and easily accessible.

We should note that statistics show that the commercial tobacco industry targets the Black Community with more advertisements, more lucrative promotions, and easier access to cheaper cigarettes compared to other communities (Henriksen et al., 2011; Seidenberg et al., 2010). These predatory marketing practices for the past 50 years have not only impacted the African American community, but young people overall.

The proposed "Endgame Initiative" will strengthen SB793, the state law that limits tobacco sales and disrupts the predatory marketing tactics used by commercial tobacco companies, which disproportionately affect poorer communities, marginalized groups, youths, and communities of color.

In November 2019, we testified before Congress in support of HR 2339 (The Pallone Bill), which would have prohibited the manufacturing and selling of menthol and all flavored tobacco products in the U.S.The bill passed the House in February 2020 but did not advance in the Senate. In June 2020, the AATCLC and Action on Smoking and Health (ASH) filed a lawsuit against the FDA for failing to remove menthol from the market, backed by strong scientific evidence that the FDA should have acted immediately. Later, the American Medical Association (AMA) and the National Medical Association (NMA)

joined the lawsuit as plaintiffs. When the FDA began the rulemaking process, we withdrew the lawsuit. We filed a second lawsuit on April 2, 2024, after the FDA had not acted for more than seven months beyond its initial deadline to finalize the new rule, extending the agency's 15-year delay in equitable policymaking.
