Friends,

I want to call to your attention a town issue. In a very short period of time, Ross has gone from having a fully staffed firehouse to having none while paying \$2.7M in a grossly unfair contract to Ross Valley Fire District for materially worse emergency response times. Few in town understand this, nor the tens of millions of dollars of CAPEX forthcoming for town consideration.

While I explain more below, a key community meeting is happening this Thursday (1/8) at 6:00pm in at the Marin Art & Garden Center Livermore Room. I encourage you to get educated and join in person or [by Zoom](#). ([Add to Google Calendar here.](#))

Key facts:

- Despite overwhelming public attendance and outcry at a March 2025 Council meeting, a 3-2 split Town Council refused to explore alternatives to closing the fire station:
 - Salter & Robbins supported exploring alternatives
 - McMillan, Dowling, & Kircher voted against
- Ross firefighters were reassigned to the other three RVFD stations in San Anselmo, Sleepy Hollow, and Fairfax. The Ross fire engine was sold. Station #19 (San Anselmo) became Ross' primary fire engine.
- This contract is unfair. Ross represents 9% of the population and 7% of incidents RVFD serves, but our \$2.7M pays 23% of costs.
- The Town Council decision was informed by:

(1) A 2021 survey only ~300 of us responded to in the heart of COVID,

(2) A proposed \$14.6M renovation of Town Facilities which has morphed into what may cost the town \$30M when finally completed, which will not include a firehouse, and

(3) A stipulation emergency response times would not increase for 85% of calls. However, at the December 8th Town council meeting, fire department officials reported response time for fire engines increased from 7:55 minutes to 10:56 minutes. Citygate's best practices goal is 7:30 minutes. The response time for the ambulance for this period is 14 minutes 2 seconds.

In October, Friends of Ross Firehouse submitted 329 petition signatures in support of a ballot initiative to restore local fire engine service in Ross. On Thursday, Friends will present a plan to renovate town facilities for \$12M and return fire staffing to Ross for less than current annual budget levels. The plan is designed by experts in EMS & firehouse architecture, structural engineering, fire safety consulting and supported by a bona fide bid from a construction firm which has built 24 fire and emergency buildings in the region including San Rafael and Corte Madera.

If a fire station isn't renovated now, then Ross will NEVER have space for a fire engine and will always be dependent on other towns for emergency services, with very little input into how those services are delivered.

The future of our Ross firehouse—and the historic civic character of our town—deserves expert analysis, community input, and a democratic vote.
